NOTIFICATION

Karachi, the 25th day of April, 2005

In exercise of the powers conferred by sub-section (1) of section 35 of the Central Depositories Act, 1997 (XIX of 1997), Central Depository Company of Pakistan Limited, being a central depository, has made with the prior approval of the Securities and Exchange Commission of Pakistan, the following amendments in the "Central Depository Company of Pakistan Limited Regulations" which shall come into force on the publications of this Notification in the official gazette of Pakistan:

1. In Regulation 2.11.1:

(a) in the definition of "Admission Form"

(i) the semi colon and the word "or" appearing at the end of item (d) shall be substituted with a comma, and

(ii) item (e) of that definition shall be deleted.

(b) in the definition of "Agreement"

(i) the semi colon and the word "or" appearing at the end of item (d) shall be substituted with a comma, and

(ii) item (e) of that definition shall be deleted.

(c) the definition of "Cash Deposit Account" shall be deleted.

(d) in the definition of "CDS Element"

(i) the word "or" appearing at the end of item (d) shall be deleted; and

(ii) item (e) of that definition shall be deleted.

(e) the definition of "Debit Cap" shall be deleted.

(f) in the definition of "Delivery", the words "or as a DvP Delivery" shall be deleted.

(g) the definitions of "DvP Account Holder", "DvP Account Holder Agreement", "DvP Amount", "DvP Counterpart Account Holder", "DvP Delivery", "DvP End of Day", "DvP Initiating Account Holder", "DvP Pending Position", "DvP Rejection Transaction", "DvP Request", "DvP Request Transaction", and "Pending DvP Request" shall be deleted.

(h) in the definition of "Pending Transfer Out Position", item (a) shall be deleted.

2. In Regulation 3.11.2, the comma followed by the words "a DvP Account Holder" shall be deleted.

3. Regulations 4.5 and 4.6 shall be deleted.

4. In Regulation 4.14.1:

(a) the word "or" shall be inserted at the end of item (b);

(b) item (c) shall be deleted; and

(c) the comma followed by the words "a DvP Account Holder Agreement" appearing at the end of that Regulation shall be deleted.

5. Regulation 4.15 shall be deleted.

6. In Regulation 4.16.1 the comma and the figure "4.5.1" shall be deleted.

7. In Regulation 4.16.2, the comma and the figure "4.6.1" shall be deleted.
8. In Regulation 5.5.1:
- (a) the semi colon and the word "and" appearing at the end of item (a) shall be substituted with a full stop and
- (b) item (b) of that Regulation shall be deleted.
9. Chapter 10 shall be deleted entirely.
10. In Regulation 15.5.1:
- (a) the word "and" shall be inserted at the end of item (c); and
- (b) items (d) to (f) shall be deleted.

GENERAL REGULATIONS

Whereas after repeal of the Defence Housing Authority Lahore Ordinance 1999 (Punjab Ordinance LI 1999), Chief Executive's Order No. 26 of 2002, for the reconstitution of Defence Housing Authority Lahore, has been promulgated and published in Gazette of Pakistan dated September 19, 2002.

And whereas, the Executive Board of the Defence Housing Authority (D.H.A) is empowered to make Regulations under Article 23 of Chief Executive Order No. 26 of 2002 and to get them published in Government Notifier in the Official Gazette.

And, therefore, in exercise of the power under Article 23 read with Article 4 and all other enabling provisions: (a) for the management and administration of the affairs of the Authority and (b) to provide and regulate housing facilities effectively in the area notified by the Authority, the Executive Board is pleased to make the following regulations:-

1. Short title, Commencement and Extent :

- (a) These Regulations shall be called Defence Housing Authority General Regulations, 2007.
- (b) These Regulations shall extend to the whole area controlled by the Defence Housing Authority, Lahore.
- (c) These Regulations shall come into force with effect from the date of publication in the Official Gazette and shall be read in consonance with all other Defence Housing Authority Regulations and vice versa.

2. Definitions:

- ing expressions shall have the meanings hereby respectively assigned to them, that is to say:-
- (a) "Administrator" means the person appointed by the Chief of the Army Staff under Clause (5) of Article 4 of the Chief Executive's Order No. 26 of 2002.
- (b) "Allottee" means a registered person to whom an allotment is made.
- (c) "Approved" means approved by the Authority.
- (d) "Approval" means approval by the Administrator of the Authority.
- (e) "Authority" means Defence Housing Authority, Lahore.
- (f) "Board" means Executive Board of The Authority.
- (g) "Chairman" means the Chairman of the Governing Body of the Authority i.e. the Secretary, Ministry of Defence constituted under sub-clause (a) clause (1) of Article 4 of the Order.
- (h) "Competent Authority" means the President and the Administrator and/or such Director or Secretary or Officer of the Authority to whom the relevant powers have been conferred or lawfully delegated.
- (i) "Order" means Chief Executive's Order No. 26 of 2002.
- (j) "Plot" means specific area of land as a sub-division showing the location and boundaries of individual pieces of land or the plots which were created as a result of further sub-division of plots within a plot with streets, alloys, easement etc.
- (k) "Prescribed" means prescribed by the Authority.
- (l) "President" means President of the Executive Board, constituted under clause (3) of Article 4 of the Order.
- (m) "Property" means property of the Authority.
- (n) "Registration" means enrolment of a person with the Authority at the time of allotment as well as transfer of the property.
- (o) "Registered Person" means a person, whether natural or legal, who is registered under the General Regulations of the Authority.
- (p) "Regulation" means Regulations made by the Executive Board under Article 23 of the Order.
